TERMS AND CONDITIONS

- · All subscriptions must be paid in advance
- · Purchase Orders (POs) can remain open for up to 6 months for incremental deliveries
- · Volume tier pricing applies to total units on a single PO
- A minimum initial delivery of 25% total PO quantity is required to confirm volume tier pricing
- · If distributor exceeds their projected volume within the 6-month window, they qualify for the next tier's discount on additional units
- Failure to fulfill the entire PO within the 6-month window may result in price adjustments on future orders
- · OmniDock does not advertise or enforce MSRP; distributors have pricing flexibility as value-added resellers
- · Pricing effective as of April 14, 2025

RENEWAL POLICY

- · Subscription renewals qualify for the same volume tier pricing as new subscriptions
- · Renewals processed within 30 days prior to expiration maintain continuous service
- · Distributors will receive renewal notifications 90, 60, and 30 days before customer subscriptions expire
- · Volume from renewals and new subscriptions can be combined to qualify for higher volume tier discounts
- \cdot Lapsed subscriptions may be subject to reactivation fees if renewed after expiration
- · If a subscription lapses without renewal, Frontier Precision will cover the cost of return shipping for the dock back to our facility
- · End customers must make docks available for pickup within 10 days of subscription expiration
